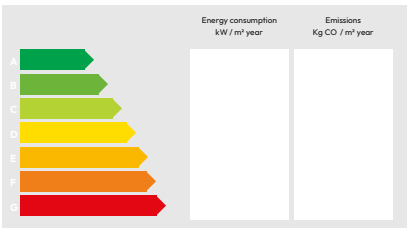


Calefacción
