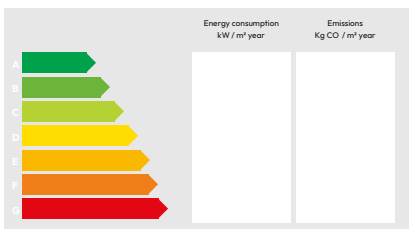


About the property: 041330
