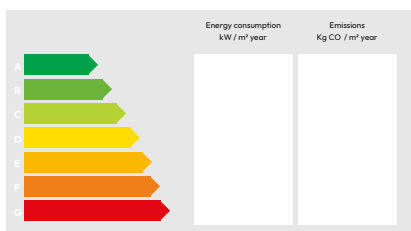


About the property: 041331
